PART 11- ALLOWANCE TO WITNESSES

Merchants, captains of ships, mercantile assistants and any officer in the public service whose income is N50,000 or more but less than N100,00.... N500 per day

Officers in the public service whose income is less than N50,000 a year... N350 per day

Any other person whose annual income is below N50,000 per year....... N350 per day

A married woman who is not gainfully employed shall be paid fifty percent of the allowance that would be payable to her husband as specified in the Part....

- a) Transport allowance per kilometre for use of private car N100
- b) Transport allowance per kilometre for use of private motorcycle ... N50

Note:

The travelling expenses of witnesses shall be allowed according to the sums reasonably and actually paid...

No allowance is payable personally to an officer of the public service who is summoned as a witness by the state or by any Department of the Government.

Allowances payable to an officer in the public service shall be paid into revenue unless otherwise ordered.

ANAMBRA STATE PROPERTY AND LAND USE CHARGE (APLUC) TAX

The following formula shall be used to determine the annual amount of the Land Use Charge payable under the Law:

Land Use Charge = (Land Value + Building Developments Value) x Charge Rate -Relief Rate

Interpreted as,

$$LUC = [(LA \times LR) + (BA \times BV)] \times CR - RR$$

Where:

LUC = Annual amount of Land Use Charge in Naira

LA = The area of the land parcel in square metres.

LR = The average Market Value of a land parcel in the neighbourhood, on a per square metre basis in Naira.

BA = The total developed floor area of building on the plot of land in square metres, or the total floor area of apartment unit in a building where the apartment has a separate ownership title.

BV = The average construction value of medium quality buildings and improvements in the neighbourhood, on a per square metre basis in Naira based on the market value of the property.

CR = The annual charge rate expressed as a percentage of the assessed Market value of the Property as stipulated in Appendix 1.

RR = The rate of relief from the Land Use Charge which is the general relief in addition to any of the qualified specific relief that may be granted by the Chairman Anambra State Internal Revenue Service upon application by an eligible property owner as stipulated in Appendix 11.
